

# Habitat for Humanity®

Aitkin County Habitat for Humanity, Aitkin County Soil and Water Conservation District, Aitkin County Child Abuse Prevention Council, Lakes and Woods Horticultural Club and neighborhood volunteers partnered with Lakes Area United Way.

A rain garden was installed at the new home in Aitkin. It is an environmentally-friendly project, which will filter runoff and rainwater before it flows into the Mississippi River watershed.

Through partnerships and volunteers, we were able to complete the planting of a rain garden at 218 Minnesota Ave. S., Aitkin. This is the Habitat for Humanity home of Kara Anderson and her children, Addie, fourth grade, and Damon, kindergarten.

#### Summary of work

In the fall of 2021, we obtained a water management grant from the Aitkin County Soil and Water Conservation District. This was used to landscape and install pipes and waterways to



direct runoff to the bottom of our lot at the new home at 218 Minnesota Ave. S. We also accomplished other erosion prevention projects with that grant.

In the spring, Jean Pitt, retired extension educator, completed a thorough landscaping plan for the home. Then, Ann Schwartz, Aitkin County Habitat for Humanity Director, made a presentation to the Lakes and Woods garden club and obtained some volunteers and donations of plants.

On Sept. 6, 2022, we held a planting party at the home. This was to engage the partner family children, neighborhood children, and various adult volunteers in completing the planting and mulching of a rain garden at the bottom of the hill. This prevents unwanted runoff into the area watersheds, including the Ripple and Mississippi rivers.

We planted the garden and had a cookout. All who attended received gardening aprons. We had five adult volunteers and eight children and youth involved in the project.

Ongoing, the family had to finish mulching the space. Also, we are anticipating

more donations of perennial plants from garden club and community members that we hope to plant this fall. We also went back and reseeded the hillside to prevent erosion. (Further planting is delayed till spring).
